# **Duties and Responsibilities**

The key duties and responsibilities of the position will be listed below.

- Strengthen and support CSOs to help them demand accountability from government stakeholders through CSO advocacy and accountability accelerator program.
- Identify, develop capacity, and empower civil society groups by providing them with adequate information, technical support, and resources on air pollution.
- Develop training modules for advocacy, accountability and accelerator program on air pollution issues, related policies and standards, its impact on environment and human health, and role of civil society in public policy advocacy and accountability to strengthen CSOs through trainings, mentorships.
- Capacitate selected CSOs to advocate for improving air quality by working with their respective wards/municipal officials and authorities on effective and efficient micro level initiatives.
- Provide series of formal and informal capacity building sessions (in-person and online platforms) for community-based advocates and their supporters to share experiences, evidence, and approaches.
- Support platforms for periodic interactions, progress updates that foster and promote cross-learning from experiences within and across sectors and beyond.
- Link advocacy to capacity strengthening expertise and experience at various level.
- Gather and share data, research, and lessons learned across the field of advocacy and accountability.
- Support the advocates to connect with the local level government including ward offices which is more accessible and where they have higher probability of creating impact.
- Generate knowledge materials on advocacy to improve civil society and media capacity for effective public policy advocacy.
