

# **Training Outline**

## Training on Introduction to Citywide Inclusive Sanitation (CWIS)

LENGTH: 3 Days

#### TRAINING DESCRIPTION:

Nepal has been declared an open defecation free country and moving towards the total sanitation. In this context, various approaches are being implemented for the attainment of the goals and targets shared related to total sanitation. One of such approach forward for the attainment of sanitation sector targets is citywide inclusive sanitation (CWIS). Hence, the training package delivers knowledge and practices related to CWIS implementation.

The training focuses on knowledge on CWIS while reflecting the information in the practices followed in different areas of the sector.

#### **OBJECTIVES:**

The main objectives of this training are:

- Describe the CWIS concepts with cohort learning
- Apply CWIS lens while implementing any sanitation related activities or project for the inclusive, safe and sustainable outcomes
- Sensitize on major roles and responsibilities of stakeholders for the effective implementation of CWIS approach for the improved public health impacts

#### **PARTICIPANTS:**

The primary target audience of the training are the professional engaged at implementation level of any sanitation projects or activities. Basically, the engineers responsible for implementation and decision making of sanitation projects, section chiefs of municipalities, other related professionals engaged in WASH sector are the targeted audiences of the training.

#### **METHODS OF TRAINING:**

Participatory approaches are used to engage and actively involve everyone in the training. This training includes power-point presentations, demonstration, group activity, participatory activities, video show and varied discussion types to share experiences. Active participant engagement in all learning activities is encouraged.

- Sanitation and its linkages with urban development and planning
- CWIS approach, its principles and frameworks for sanitation service delivery
- Existing laws, rules & regulations as an enabling environment
- CWIS service outcomes- Equity, Safety and Sustainablity
- CWIS system functions- Responsibility, Accountability and Resource Planning and Management,
- Implementing CWIS- Putting All Together (CWIS Planning, Implementation, Monitoring, Evaluation and Evidence-based Decision Making)

#### **OUTCOMES:**

At the end of this training, the participants will be able to

- Incorporate CWIS into the plans and implement it
- Link WASH plan to sanitation and CWIS
- Discuss urban Sanitation and Public Health impacts
- Introduce the CWIS, principles and framework
- Discuss the legal and policy provisions across sanitation service chain in Nepal
- Discuss the components of CWIS framework equity, safety, sustainability, responsibility, accountability and resource planning and management
- Apply CWIS lens in the sanitation activities or projects
